It is notified for information of all concerned that Written Test in respect of **Assistant Editor Examination-2025** will be held as per the following details:-

1. Date of Examination

15.02.2026

2. The duration of the written examination shall be two (02) hours.

3. Scheme and Mode of Written Examination

(a) The Question Paper shall comprise four (04) judgments.

(b) Candidates shall be required to prepare headnotes of any one judgment out of the four judgments provided.

(c) The prescribed format for preparation of headnotes will be shared with the candidates along with the question paper at the examination centre thirty (30) minutes prior to commencement of the examination.

(d) Candidates shall save their prepared headnotes on the computer systems (desktops) provided at the examination centre within the stipulated time.

(e) A rough sheet will also be provided to the candidates for preparing rough notes.

4. Marks and Evaluation Criteria

(a) The maximum marks for the examination shall be **100 marks**, comprising:

(i) Written Examination – **60 marks**

(ii) Interview – **40 marks**

(b) Marks shall be awarded on the basis of identification of statutes/law involved, issues under consideration, rationale behind findings on legal issues, conclusion and articulation.

5. Minimum Qualifying Marks

(a) Minimum qualifying marks in the written examination shall be **40 out of 60**.

(b) Minimum qualifying marks in the interview shall be **20 out of 40**.

6. Tie-Breaking Criteria

In case of a tie, preference shall be given in the following order:

(a) Past experience as Assistant Editor with the e-DHCR Project;

(b) Seniority in age as per Bar Council records.

7. It is further notified that the details of reporting time, time and place of Test and instructions to candidates, etc. will be as per the Admit Card and the link for downloading the Admit Cards for the aforementioned exam will be available on the website of this Court as per details given below:-
