The Executive Committee arrived at the above decision after duly noting that though multiple representations had been made to the Hon'ble High Court, seeking reconsideration of the said decision, however, no reconsideration had taken place.

In this regard, the Executive Committee also considered the representations received from the members of the Bar highlighting the serious practical difficulties arising from Saturday sittings. Members had expressed that the present arrangement would cause significant disruption to their professional schedules, including appearances before various tribunals, arbitrations, mediation and courts outside Delhi. The Committee also took note of the adverse impact on preparation time, client meetings and overall professional efficiency.

As such, all members of the Delhi High Court Bar Association are requested to co-operate and abstain from work on the 1<sup>st</sup> and 3<sup>rd</sup> Saturdays of every month, starting from 04.04.2026. Further, it is
